#### VI. Discussion Items:

- a.) Charter Renewal Process- Amy Gygax Thanks to Michelle Zendell, for joining us to help us understand the process of charter renewal that we will need to start working on. Michelle Zundell I am providing you with a calendar of the renewal process. Before Winter Break you will send in a letter of intent to renew your charter. In that letter you can request any changes that you want to be made. Within 15 days of receiving that letter the district responds with requesting changes they need, and if the schools requested changes will be acceptable. Within 15 days of the district letter the school responds with additional information. Within 45 days of initial renewal request a public hearing will be scheduled. Ten days after that the district tells you of the intetion to renew, within twenty days they tell you in writing. Within 90 days of the district dision the parties meet to negotiate the charter. Were the district to decide not to renew you would have 10 days to resubmit charter.
- **b.**) Strategic Plan Amy Gygax We need for a committee to meet and put together a timeline for the objectives that we have come up with. I will get those objectives written up as part of the Strategic Plan, and we can start that committee in the fall. **Leann Tourzan** I would like to meet before school starts. 10 am. July 31<sup>st</sup>.
- c.) Board Self Evaluation- Amy Gygax One thing that I noticed that we could use some improvement on is the greater community relationship. Monica Rathjen It could be valuable to invite board members from other schools to attend our meetings, and, in turn go and visit their meetings. Amy Gygax I have been approached by the Siskiyou Board president, about how we could work together. We should also have a goal of getting more work done ahead of the meetings, so that we can use our meeting time more efficiently. Kellee O'Shea Since we have so much to do, should we start meeting more regularly? Amy Gygax We could add a work session, where we can talk about a few things. Let's plan it for Sept. 16<sup>th</sup>, at 5:30.

- d.) Family/Medical Leave Amy Gygax I revised the document from our last work session, and would like everyone to look over it, and send revisions and edits to me well before the next meeting. I am still working on the document about the fund that would allow for paid emergency leave. I was not sure if we wanted to make it something that all employees could apply for, or it should only be for employees that receive paid sick and personal days. I am inclines to say that it is available to everyone. Karen Bailey I also looked into short-term disability insurance, and that is something that is available to our employees.
- e.) Faculty Feedback of Director- Amy Gygax- When we were going through the Board evaluation of the Director, the faculty expressed that they would like to have a way to give feedback, and we said that we would create that opportunity, but not have it be a part of our evaluation of the director. Whatever we use, I would like it to be a way for it to be in a positive light. They should have an opportunity to say what is working well, and what might need improvement. Lean Tourzan Faculty would also like to have a follow up meeting with the board. Monica Rathjen Could we invite the faculty to come to a board meeting, or plan on the board going to a faculty meeting? Amy Gygax We can plan on having a questionnaire and follow up meeting between board and faculty in March or April.
- **f.**) **Board Retreat- Amy Gygax** We had talked about bringing someone in to do our biography work, but we haven't found anyone. Karen, would you be willing to run that part of the retreat? **Karen Bailey** Yes **Amy Gygax** The second half of the retreat we will work on charter renewal. **Amy Gygax** Should we start with lunch at noon? We can have a potluck.
- **g.**) **Financial /PERS work session Amy Gygax-** We should plan on doing a work session in September.

- i.) Board Faculty- Amy Gygax Jane is away, and she was selected to come back and serve another term on the board, but since Jodie is now a faculty member, she might take her place. I also think that we need to reevaluate having a faculty member as a voting board member. In the past, they have recused themselves on votes that might be a conflict of interest, but I am not sure that it is a good idea to have faulty members as board members. My main concern with Jane serving on the board, is that all the parents that are on the board have a child in her class. If any issues were to happen in that class, it could be a problem.
- **j.**) **Reimbursement for Training- Karen Bailey** There are two teachers, Hannah Jackson, Leann Tourzan and one former teacher Alyssum Barber, who have a

balance due to Rudolf Steiner College, and they have told me that Joe Frodsham promised to pay for their tuition there. I want to know what the board thinks I should do. **Amy Gygax** We should consider what the numbers are. We can leave it up to what you think Karen. **Karen Bailey** I think we can pay for Hannah, and Leann, but I don't know about Alyssum, she is no longer a teacher here.
