#### 3. Discussion item:

- a. Directors search (5 min) Amy Rudolph & Katherine Holden We have next candidate coming in next week. Wednesday Thursday and Friday morning. Parent tea will be Friday morning in the Kindergarten room. Last candidate requested to be confidential. Hannah Jackson: will she be able to meet the board members? Katherine Holden she was given the option to meet with the board but could not be here tonight because of a conflict in schedule. Joe you have a staff meeting on that Wednesday will you be able to give her some time at that meeting. Joe Frodsham I think it is really important for the board to meet the candidates since it will be the board who will be making the decision. Lorraine McDonald I did talk with Mechtild about this also because she too had voiced a concern about this. Katherine Holden our first candidate was very pleased with her visit she said she felt very welcome. Jane Higgins she actually voiced the same to me. Katherine Holden hopefully after next week we will have a better feel for an appropriate candidate. Perry Hart we would need to meet as a committee first and then present to the board at the next meeting. Jane Higgins we were given a form to fill out about the last candidate who has those? Amy Rudolph I have them Katherine Holden committee will review them at the next meeting. We also have some from the parent tea and some from a few of the students. We debriefed right after the interview with Karin which was really nice then the committee met 5 days later. Mark Sievert in general how are the faculty sitting with the candidates. Jane Higgins we are really just being open with the candidates we did spend a couple of hours with her? Mark Sievert I may have missed something but why was Joe not more on the committee. Katherine Holden it was just felt that it might be a little awkward for the person who may be potentially taking over his position. Amy Rudolph Did you have an opportunity to meet with Karin? Joe Frodsham I did have a chance to sit and talk with her briefly. Lorraine McDonald We didn't want 16 people on the hiring committee. Joe Frodsham I have been on two hiring committee's for superintendent and the entire board was on the committee with a couple of other community members and parents. Lorraine McDonald I had a good amount of time to spend with Karin and I came back with a really good feeling. Katherine Holden I would like to extend the invitation to the board to meet with the candidate during the dinner with the candidate. Lynn Sullivan can I let you know next week I like the dinners it is more casual and you really get to know the candidates.
- b. 8<sup>th</sup> Grade exit interviews: Lorraine McDonald 8 of the 16 have been completed 2 have been very difficult to get ahold of if you have been feeling really overwhelming give them to me and I will try to see what I can do. Joe when do you need these by? Joe Frodsham I would like to give them to the board when they come next week for their annual visit but if not we have to turn in by February 1<sup>st</sup>. Mark Sievert I know most of the families from the 8<sup>th</sup> grade class so if you want I will try and get ahold of them. I will contact the Wells family and the Catlett family this next week.
- c. 8<sup>th</sup> Grade cutoff policy (10 min) Hannah Jackson There is a conversation with the faculty how we can affectively help the students in the 8<sup>th</sup> grade class. Some students coming in from other schools with difficulties from other schools. Or coming in mid-year, 8<sup>th</sup> grade trip fundraising, violin, handwork, Spanish, what our policies for kg and 1<sup>st</sup> grade class room if we could create a policy for admitting new students into the 8<sup>th</sup> grade class room. Amy Rudolph so you want to make a policy to not allow students coming into the 8<sup>th</sup> grade class room? But allowing returning students or other students coming from another Waldorf school. Hannah Jackson it is such a celebratory year there is a question of legalities with policy and would like to get the ball rolling Mark Sievert so a cut off for everyone with the teacher making an exception Lorraine McDonald They have already denied a waiver for our kindergarten for giving preference to Waldorf Preschoolers. I did talk with Joe a little about this to see

if it would be possible. Joe Frodsham I talked to the lawyers before Christmas and we have to accept a student if we have an opening. I asked if we could cap the class and they said yes, we could but that still leaves a possibilities of some moving and still having an opening. Katherine Holden if you say this is our class size then if there is an opening we have to accept students. Lynn Sullivan it sounds like the teachers would take the risk of not having a good student would be worth the cap of the class. Lorraine McDonald I can definitely tell you that it is not legal to deny student. Katherine Holden this is not unique to Madrone this is District wide it is not easy with the culture of the pedagogical beliefs. Weighing this out every teacher in every public school has this dilemma. Hannah Jackson this is just something that has been really discussed about Amy Rudolph before we make any decision we would need to also look at our budget because there may be a number that we cannot go below. Jane Higgins I can say that it is not so much an academic problem as much as it is behaviors. If you are having the students year after year and then you get a behavior problem it throws the whole class. Lynn Sullivan my son has come home and said everything was fine until so and so came into class. Jane Higgins It may not work but we just want more questions asked. Lorraine McDonald It sounds like we have we have talked with the OSBA you cannot have an enrollment policy in a public school unless the State has given us a waiver. Hannah Jackson what I am hearing is I think, I don't know? We want a straight answer as to what we do know. Mark Sievert could we recommend they start in the 7<sup>th</sup> grade? Tracy Boykin no there is a huge process to retain a student, involving special education. Perry Hart the other option is what Joe does by sitting with the parent and being direct about the success of the student and Madrone Trail. Is there a way to set up a meeting or contract with children about these are your obligations and if they are not adhered to then it will result in expulsion. Joe Frodsham one of the students last year that gave us a lot of issues was because I took too long in implementing the suspension hoping that it will get better. Lynn Sullivan would be beneficial to have them do a placement test to let them know that will let them know that this is a huge commitment. Lorraine McDonald we could look into the process and see if we can require the placement in one grade and not another. **Hannah Jackson** We want a policy first priority for a cap on the 8<sup>th</sup> grade classroom. Lorraine McDonald the answer is yes, we will start the process of creating a policy. Jane Higgins I think however we can bring it to meet the needs of the class and the teacher, if that is the way we have to do it then it is a good start. Katherine Holden can we add a student component to the enrollment process for the upper grades. Joe Frodsham I still have some issues with taking away the possibility of getting some really great students. Jane Higgins we have to look at what we want for our 8th grade class, it is a year of closing out the elementary not a new beginning. Hannah Jackson as a faculty it was a resounding no, we would rather not accept new student into the 8<sup>th</sup> grade classrooms.
